Your Personal Data

What we need

As part of the process of registering as a member of Percy Park RFC we will only collect relevant basic personal data about you which does not include and special categories of personal information (often known as sensitive personal data with the exception of relevant medical information as described above). The information does however include the likes of your name, address, email address, data of birth and contact details. If you become involved with coaching then details of all your training qualifications / DBS information will be kept.

Why we need it

We need to know this basic personal data in order to register you as a member of Percy Park RFC on the Game Management System (GMS). The GMS is owned, and controlled, by the RFU and is the central repository for all English rugby clubs. We will not collect any personal data from you that we do not need.

What we do with it

All the personal data you provide is entered onto the GMS by the club's registration officer. Once entered then any hard or soft copies are destroyed. No other parties, other than designated club officials, will have access to your personal data unless there is a legal obligation for us to provide it.

We will use your contact details to keep you informed of any events relating to Percy Park RFC.

How long do we keep it

We will keep you data for the duration of your membership after which time and/or at your request, it will be deleted.
